Describe present and historic physical appearance:

Located at 401 W. Pine Street in downtown Cabot, Lonoke County, the Dr. E. F. Utley House is a two-story, frame residence with Colonial Revival-style detailing constructed sometime between 1914 and 1922. There are a number of notable architectural features, including four gabled dormers with diamond patterned shingles, a single-leaf door with oval beveled glass, a sixteen light transom and beveled sidelights, and an interior Tuscan columned screen.

Elaboration

Located at 401 W. Pine Street in downtown Cabot, Lonoke County, the Dr. Utley House is a two-story, frame residence of the type commonly known as "American Foursquare" with Colonial Revival-style detailing. Constructed sometime between 1914 and 1922, the building rests upon a continuous brick foundation, and the two-story frame walls are clad with narrow-width weatherboard. Later wide steel siding was added over the original wood siding; this steel siding has now been removed. The hipped roof is sheathed with composition shingles and features a gabled dormer on each elevation. Each dormer features boxed cornice returns, regular and diamond-patterned shingles, battered walls, and a Palladian-esque window with a central six-over-one double-hung window flanked by four-pane casement windows. There are no extant chimneys above the roofline. Utley House Name of Property

The front, or northeastern, elevation is defined by a slightly raised, early full-length, one-story porch which wraps around to the southeastern ide elevation. The porch is covered by a flat roof with boxed gutters and supported by four tapered box columns on the front elevation and two additional columns on the side elevation. Cornice moldings and other trim adorn the porch eave and provide a classical entablature appearance. Beneath this, the principal entrance is positioned to the southeast of the facade while a large sixteen-over-one, double-hung wood window is placed to the northwest. The single-leaf wood door contains a large, beveled-glass oval-shaped light and is surrounded by sidelights with similar, yet narrower, beveled-glass, oval panes and a rectangular, sixteen-pane transom. The second-story of this elevation is symmetrically fenestrated by two sixteen-over-one, double-hung wood windows.

The southeastern side elevation is composed of eight windows in four bays. Six of the windows are the original nine-over one, double-hung type while the first story kitchen and bathroom windows have been replaced with modern one-over-one, aluminum-frame windows.

Originally, a two-story, screened sleeping porch extended across more than half of the rear, or southwestern, elevation. This was later enclosed by the application of the aforementioned steel siding. Now the first story area is covered with weatherboard of the same width as the rest of the building and the second story features vertical beaded-board beneath the windows. The first story contains a central single-leaf entrance and another one-over-one, aluminum-frame kitchen window to the southeast. The cond story is fenestrated by a ribbon of aluminum-frame windows orresponding to the original sleeping porch and a single nine-over-one, double-hung wood window.

The northwestern elevation is more asymmetrically composed than the other elevations. The first story features a projecting hipped-roof bay placed to the south of the center. It contains a central nine-over-one, doublehung, wood window flanked by two much slimmer nine-over-one windows. A larger nine-over-one window is positioned to the north of the bay on this story. The second story is fenestrated by a nine-over-one window above its first story counterpart, a small two-over two, aluminum-frame window, a pair of nine-over-one windows above the projecting bay, and a small fourpane wood casement window on the southern, sleeping porch section.

Noteworthy interior details include: a half-turn staircase with turned balusters and square newel posts with carved relief, original hardwood flooring, wood pocket doors, a Tuscan columned screen between the entrance/staircase room and the parlor, and a wood mantelpiece embellished with egg-and-dart molding and two unfluted columns with composite capitals. The acoustical tile on the downstairs ceiling was removed in the course of the recent restoration.

There is one nonhistoric garage located behind the house.

State significance of property, and justify criteria, criteria considerations, and areas and periods of significance noted above:

Summary

The Dr. Utley House is being nominated to the National Register of Historic Places under Criterion C as the best example in Cabot of an American Foursquare residence embellished with Colonial Revival-style detailing.

Historical Background

Although the builder and original occupants are unknown, the Dr. E. F. Utley House is believed to have been constructed between 1914 and 1922. During the period of construction, Cabot was still a relatively young and growing town. Located on the Missouri Pacific Railroad, Cabot was incorporated on February 22, 1897. According to Dallas T. Herndon's Centennial History of Arkansas, Cabot has a population of 447 people in 1920 and could boast of "a weekly newspaper, a bank, two nurseries, and a telephone exchange." Lonoke County, Arkansas County and State

The nominated property is known as the Utley House by the older residents of Cabot because of its association with Dr. E. F. Utley, who owned and resided in the house from c. 1935 to c. 1955. Utley was a "horse and buggy" practitioner who also tended patients at his home.

Architectural Significance

The Utley House, derives its primary significance from its architecture. Apparently, there were at least two other nearly identical houses constructed in Cabot along with the Utley House. Today, only the Utley House remains, and it is the best example in a town of a large, American Foursquare residence featuring Colonial Revival-style decorative elements. This property was placed in the Arkansas Register of Historic Places while the artificial siding was still on it. Recently the owners removed the steel siding, replaced the failing porch roof, removed the acoustical tiles on the interior ceiling and the historical integrity of the house has been restored. For these reasons it is now being nominated to the National Register of Historic Places under Criterion C.
