Miss Sophia Sawyer who accomanied Mrs. Ridge and her children later started the Fayetteville Female Seminary. Miss Saywer is credited by the late W. J. Lemke, Washington County historian, as providing the influence which led to the establishment of the University of Arkansas. An extension of this thinking would make the Ridges the spiritual founders of the University of Arkansas, a legacy completely in keeping with their unfailing support of education of the Cherokees.
