

## Summary Paragraph

This amendment seeks to add 54 contributing buildings to the Central High School Neighborhood Historic District and increase the number of contributing buildings within the district 590. It also contains a re-evaluation of the buildings in the existing district based on a resurvey that was undertaken on the 2000s. The boundary for the Central High School Neighborhood Historic District will be expanded to the west side of Dr. Martin Luther King Drive between West 17<sup>th</sup> Street and Wright Avenue. The amendment will also increase the district's period of significance from ca. 1870-1954 to ca. 1870-1961.

Almost all of the development within the expanded boundary occurred post World War I, with 44 (83%) of the 54 contributing structures constructed between ca. 1920-1961. Twenty-six of these structures were constructed in the interwar period and 13 were constructed post World War II. One historic structure was constructed prior to the twentieth century (PU4280). The remaining 8 (15%) historic structures within the expanded boundary were constructed in the twentieth century prior to World War I. One structure, The John Henry Clayborn House, was previously listed in the National Register of Historic Places (NRHP) in 2006.<sup>1</sup>

## Narrative Description

The majority of the area within the expanded boundary is residential in nature, with only one contributing commercial property (PU4331), a contributing religious property, the Pilgrim Valley Baptist Church (PU4269); and one property belonging to the Arkansas Baptist College (PU4318). The expanded area is bounded to the east by Dr. Martin Luther King Drive and to the south by Wright Avenue, major thoroughfares south of downtown Little Rock, Arkansas. It is bounded to the north by West 17<sup>th</sup> Street and to the west by South Summit Street from Wright Avenue to West 18<sup>th</sup> Street and by South Battery Street between West 18<sup>th</sup> and West 17<sup>th</sup> Streets. The current Central High School Neighborhood Historic District surrounds the expanded boundary on the north, south and west sides. The buildings located within the expanded boundary reflect the varied architectural styles prevalent from ca. 1895-1961.

### DESCRIPTION

This nomination expands the boundary of the Central High School Neighborhood Historic District, which was listed in the National Register in 1996 and amended in 1997 and 2004, to include contiguous historic development on the east side of the present district, thereby expanding the boundary to the west side of Dr. Martin Luther King Drive between West 17<sup>th</sup> Street and Wright Avenue. It also re-evaluates the resources in the existing district through a resurvey that was conducted in the 2000s. By way of this boundary increase, the district will be expanded to include an additional 54 contributing resources and 64 noncontributing resources, which added to the previous contributing resources and non-contributing resources listed through the original nomination and subsequent amendments, brings the total to 584 contributing resources and 472 non-contributing resources. In addition, the amendment will also increase the district's period of significance from ca. 1870-1954 to ca. 1870-1961.

The Central High School Neighborhood Historic District as amended encompasses the historic commercial, institutional and residential buildings of this predominately African-American community, and illustrates the evolution of housing practices and styles within the district. The physical characteristics of the buildings included in the boundary increase do not deviate substantially from those in the existing National Register district, but rather complement the numbers of those already listed within the district. The composition of the contributing and non-contributing resources are presented in the tables below and are described, according to general patterns and characteristics, following.

Queen Anne (2 contributing; 1 non-contributing):

Three houses within the expanded boundary reflect the Queen Anne architectural style. Constructed ca. 1895 (PU4280) and ca. 1915 (PU4336), the houses display Queen Anne elements such as spindled porches, fish scale shingles, verge board, projecting pavilions and projecting bays. The house at 1816 South Bishop Street (PU4336) also displays elements of Colonial Revival detailing, such as Classical cornice returns, which reflect its later construction during the transitory period from 19<sup>th</sup> century Victorian architectural styles to the popular architectural styles of the early twentieth century.

One Queen Anne structure (PU4313) is non-contributing because of the addition of replacement siding, windows and doors.

Colonial Revival (2 contributing):

Two houses within the expanded boundary reflect the Colonial Revival architectural style. Constructed during the interwar housing boom, these houses reflect one of the most popular architectural styles during this period. The houses are "clustered" together, a common occurrence throughout the Central High School Neighborhood Historic District. Constructed ca. 1923, the H. Ray Burks House (PU4213) displays more modest Colonial Revival elements, such as a balconied entry porch and Classical cornice returns. This is typical of the simplified Colonial Revival style popular in the early 1920s. Constructed ca. 1925, the R. L. Bennett House (PU4212) is a much more elaborate example of the Colonial Revival architectural style. It displays elements such as a balconied porch, Palladian arches,

louvered shutters on an end wall, a corbelled chimney stack and Classical cornice returns. It is an excellent example of Colonial Revival ornamentation.

### American Foursquare (3 contributing):

Three structures within the expanded boundary are of an American Foursquare plan. The American Foursquare is characterized by two-story, two-bay square or rectangular plans, low-pitched hipped roofs, front dormers and one-story, full-width front porches.<sup>1</sup> One house within the expanded boundary displays Prairie style detailing, whilst the other two display Craftsman ornamentation.

The R.R. Lynn House (PU4214), with its low-pitched hip roof with wide eaves and brick exterior, displays elements of the Prairie style. The Charles H. Boestra House (PU4215), located next to the R.R. Lynn House, exhibits numerous Craftsman elements such as rafter tails and a rusticated porch. The House at 1520 Wright Avenue (PU5926) also exhibits rafter tails and other Craftsman elements such as tapered porch posts, multi-pane upper windows and an exterior brick chimney.

### Craftsman (24 contributing; 10 non-contributing):

The Craftsman architectural style is by far the most prevalent within the expanded boundary, with 35 examples of this style present. The style is characterized by low-pitched, gabled roofs with wide eaves, rafter tails, wood shingles, knee braces, battered porch piers and tapered porch posts. The majority of the buildings exhibiting the Craftsman style were constructed during the interwar period, from 1920 to 1940. They are often found clustered throughout the expanded boundary, particularly along South Marshall and South Bishop Streets.

One Craftsman-style residence, the John Henry Clayborn House (PU4274) was listed on the National Register in 2006 under Criterion B, for its association with Clayborn, a prominent African-American reverend.

Of the 35 Craftsman-style dwellings in the expanded boundary, 27 are Craftsman Bungalows. The Craftsman Bungalow was an extremely popular house style during the early twentieth century. It was easily adaptable, with numerous variations across the country. The Craftsman Bungalow was an affordable housing option for the rapidly growing Central High Neighborhood during the interwar years.

The most prevalent Bungalow types found within the expanded boundary are the California Bungalow and the Southern Bungalow. Made popular by the California architects Greene and Greene, the California Bungalow is the typical Bungalow, using rusticated materials, and exhibiting elements such as a shed dormer, wood shingle siding, wide eaves, rafter tails, knee braces, battered porch piers and tapered porch posts. The John A. Carver House (PU4152) is the most high-style example of a California Bungalow within the expanded boundary. It exhibits elements such as rusticated porch piers, a king post, a tie beam and rafter tails. The house at 1815 South Marshall Street (PU4328) exhibits Craftsman details such as a low pitched roof with wide eaves, rafter tails and a shed dormer. While

other California Bungalows are much simpler, they all exhibit elements such as a low-pitched roof with wide eaves and rafter tails.

The Southern Bungalow is the most common form of the Craftsman Bungalow found within the expanded boundary, with 13 examples. The Southern Bungalow was a variation of the typical Bungalow. They are almost always front-gabled with space for an attic and deeper than they are wide with a prominent front porch.<sup>2</sup> Southern Bungalows are almost always of frame construction. All of the Southern Bungalows within the expanded boundary exhibit these characteristics with some variation. The House at 1823 South Bishop Street (PU5924) is a Southern Bungalow with a recessed front porch. The House at 1801 South Bishop Street (PU5917) exhibits more elaborate Craftsman detailing usually found on California Bungalows, such as rafter tails and tapered porch posts.

Four Southern Bungalow duplexes are found throughout the expanded boundary. Several are clustered on South Bishop Street. They all are front-gabled structures with a large attic vent beneath the gable and prominent, front-gabled porches sheltering each entry.

Ten Craftsman dwellings are non-contributing because of the addition of replacement siding, windows and doors, and/or additions.

Plain/Traditional (8 contributing; 6 non-contributing):

Fourteen buildings with no particular stylistic influence are found within the expanded district boundary. These buildings were constructed from ca. 1900-1951. The majority of these structures exhibit very little stylistic ornament. However, several buildings exhibit isolated elements of architectural styles, such as the A.C. Amrhein House (PU4201), which exhibits some Colonial Revival ornamentation and the house at 1700 Martin Luther King Jr. Drive (PU5937) and the house at 1720 Martin Luther King Jr. Drive (PU5933), which exhibit some Craftsman details.

Six buildings are non-contributing because of the addition of replacement siding, windows and doors, and/or additions.

American Small House (7 contributing; 1 non-contributing):

Eight structures within the expanded boundary are categorized as being an American Small House. Constructed from ca. 1930 – 1950, the American Small House was an affordable, well-built single family house that was a response to the Great Depression and the housing shortage that ensued post World War II. It is characterized by a square or rectangular plan, one or one-and-one-half-stories and a side-gabled roof, possibly with a front-gabled extension. The façade entry is almost always centered.<sup>3</sup> American Small Houses can be ornamented with various styling, although any stylistic details are always rather simple in nature. The examples located within the expanded boundary exhibit Colonial Revival or Craftsman details.

Several American Small Houses within the expanded boundary are clustered together along West 18<sup>th</sup> Street. The remaining structures are isolated throughout. They are nearly identical to one another, exhibiting a one-story, side-gabled form with a brick veneer exterior. The Dewey G. Carter House (PU4207) and the Samuel O. Whitten House (PU4209) exhibit large, front-gabled center porches, whereas the Anthony J. Kolasci House (PU4208) exhibits a flat-roof center porch. An early frame example is the House at 1807 South Bishop Street (PU5919), which exhibits Craftsman details, such as rafter tails, knee braces and a center, front-gabled roof projection.

One structure (PU4198) is non-contributing because it has compromised integrity resulting from the installation of replacement siding, windows and doors.

### Ranch (8 contributing; 8 non-contributing):

The Ranch House is the second most prevalent structure found throughout the expanded boundary, with 16 buildings. The Ranch House is the most common house form from the mid-twentieth century and beyond throughout the nation. It quickly surpassed all other residential forms within the expanded boundary post World War II, as vacant parcels were subjected to infill development and as older homes were replaced with the more modern form. The majority of Ranch Houses are scattered throughout the expanded boundary, but several are clustered along South Marshall and South Bishop Streets.

There are various sub-types of the Ranch House, but all exhibit a one-story form with a long, low roofline. Ranch houses are almost always of frame construction and can have a brick or stone veneer. The majority of the Ranch Houses within the expanded boundary are Bungalow Ranch houses. The Bungalow Ranch is as deep as it is long, with a hip roof. The house at 1713 South Wolfe Street (PU4258) exhibits a hip roof with wide eaves, a brick veneer exterior and a hip roof porch. It is also sited transversely. The house at 1704 Martin Luther King Jr. Drive (PU5936) is another example with an attached garage.

Other Ranch House sub-types found within the expanded boundary include the house at 1808 South Bishop Street (PU4335), which can be categorized as a Courtyard Ranch. It exhibits two wings that create a courtyard on its façade with an attached carport. The house at 1722 West 18<sup>th</sup> Street (PU5932) is a Linear-With-Clusters Ranch house. It exhibits a cluster of rooms at one end of the house that projects to the front. The house at 1820 South Bishop Street (PU4337) is a Compact Ranch house, the earliest form of Ranch House. It exhibits a short, rectangular form with an integrated carport.

Eight Ranch Houses are non-contributing. They all date to after the period of significance for the expanded district.

Commercial (1 contributing; 5 non-contributing):

Six commercial buildings are located within the expanded boundary, however only one is contributing. The Samuel T. Hester Filling Station (PU4331) is located at 1622 Wright Avenue, in the heart of the historic commercial corridor. The structure exhibits Art Deco details, such as recessed windows, metal panels and stepped geometric forms.

The five remaining non-contributing commercial buildings either date to after the period of significance or have been heavily altered.

Educational (1 contributing):

Constructed ca. 1960, the educational building located at 1700 South Bishop Street functions as the gymnasium of the Arkansas Baptist College.<sup>4</sup> The gymnasium historically and currently is integral to the college campus community, as well as the Central High Neighborhood, by providing a gathering place for community events. The building is a two-story, front-gabled structure with wide eaves. It is clad with brick veneer. Cast concrete panels are located beneath the gable. The gymnasium is typical of a mid-twentieth century athletic building.

Religious (1 contributing):

Constructed ca. 1960, Pilgrim Valley Baptist Church (PU 4269) is located at 1821 South Wolfe Street. The building is important to the community because it provides a gathering place for people to worship. The building is a one-story, L-plan structure with a front and side porch. It is clad with a brick veneer. A steeple extends above the roof peak at the center of the front-gabled portion. The building is typical of a mid-twentieth century church.

Vacant Parcels (38 non-contributing):

Thirty-eight of the 69 non-contributing resources are vacant lots. The majority of these lots once contained buildings that have since been demolished, many in recent years.

### Summary Paragraph

The expanded boundary of the Central High School Neighborhood Historic District adds a contiguous area of the early to mid-twentieth century middle-class, interracial neighborhood to the district's eastern boundary. While the district is associated with the nationally significant events of 1957 at Central High School, it is moreover representative of the evolution of a middle-class, interracial, mixed-use neighborhood throughout the early to mid-twentieth century, a context which this amendment area complements. The expanded boundary area's architecture, filled primarily with Craftsman, American Small House and Ranch resources, is reflective of the district's primary housing booms, during the interwar period and post World War II.

### Statement of Significance (amended)

In 1996, the Central High School Neighborhood Historic District, comprised of 417 contributing resources and 401 non-contributing resources, was successfully nominated to the National Register of Historic Places. At that time, the boundaries and period of significance for the district were defined so as to exclude a number of mid-twentieth century dwellings that did not appear to be fifty years of age or older, as well as those early twentieth century resources within this sector, and were not thought to sufficiently contribute to the significance of the neighborhood, despite the fact that they continue the evolutionary development patterns exhibited by earlier portions of the neighborhood, as its residents established an identity. Indeed, even within the nominated district, 113 resources were identified as non-contributing as having been constructed after 1947.

These buildings are now considered to contribute to the significance and integrity of the district. The expanded boundary of the Central High School Neighborhood Historic District is eligible under Criterion A in the area of community planning and development because it is representative of the evolution of an early to mid-twentieth century middle class, mixed-use, interracial neighborhood.

The expanded boundary is part of the Centennial Addition, which was originally granted to William Wilson by the U.S. Government in a land patent dated June 24, 1811. The property was then sold to Benjamin Johnson in October 1834. In 1867, the land was transferred to Ambrose H. Sevier as a result of a judgment rendered by the Pulaski County Circuit Court to settle debts.<sup>5</sup> The property was laid off into city blocks at this time.

In March 1868, Sevier sold 160 acres to John Faust, a lawyer and real estate agent. Various other transactions occurred during the 1870s between the original Wilson heirs and real estate agents wanting to purchase tracts for residential development. The Pulaski County Commissioners platted the land as Centennial Addition on March 23, 1877. The addition comprised 43 blocks.<sup>6</sup>

The area comprised of the expanded boundary was the last supplemental subdivision of Centennial Addition. It was platted on April 14, 1890 by F.M. Fulk and Florence Fulk as the Fulk Subdivision of Blocks 40-41. The area was comprised of 40 lots between 18<sup>th</sup> and 19<sup>th</sup> Streets (now Wright Avenue)

and Wolfe and Battery Streets, as well as 40 additional lots between 18<sup>th</sup> and 19<sup>th</sup> Streets between Pulaski Street on the east and Bishop Street on the west. The lots facing Wolfe, Marshall, Bishop and High Streets were the largest, measuring 50 by 150 feet, all located within the expanded boundary.<sup>7</sup>

While the neighborhood was primarily white in the early twentieth century, it, like all other areas of Little Rock, contained "pockets" of African American families. Many of its African-American residents were employed by white families within the neighborhood.<sup>8</sup> Other African American professions within the neighborhood included clergymen, barbers, chauffeurs, mail carriers and clerks, cooks and maids. Railroad employees were also property owners in the area. Some white residents were similarly employed, while others were lawyers, doctors, teachers and businessmen.<sup>9</sup>

As was the case with those portions of the neighborhood included in original nomination, where 274 resources, approximately 33%, were built during the interwar period, the amendment area also witnessed a boom in development during these years as improved infrastructure, notably water, was made available. By 1913, the block between 17<sup>th</sup> and 18 Streets and Bishop and High Street (now Dr. Martin Luther King, Jr Drive) was nearly filled in, as was the area between Wolfe and Marshall Streets and 18<sup>th</sup> Street and Wright Avenue (which by this point had been changed from 19<sup>th</sup> Street). Yet, the vast majority of land remained to be developed following the war. Indeed, the west side of Bishop Street between 17<sup>th</sup> and 18<sup>th</sup> Streets lay vacant, as did nearly the entire block between 18<sup>th</sup> Street and Wright Avenue and Marshall and Bishop Streets. The west side of Bishop Street between 18<sup>th</sup> Street and Wright Avenue also remained undeveloped until the interwar period. The sum of the land between Battery and Wolfe Streets between 18<sup>th</sup> Street and Wright Avenue also lay vacant and awaiting development, less four parcels at the southern end of this block which had already been developed.<sup>10</sup>

As the original National Register nomination aptly illustrates, in some places, residents of the neighborhood lived at the same address for over 20 years, maintaining high property values. The neighborhood at-large survived the "white flight" of the 1950s. This was most likely because the majority of its residents were homeowners, who took pride in their homes and neighborhood. The neighborhood remained one of the more desirable areas within Little Rock, as evident by the constant construction of new homes up through the 1970s. However, even during this mid-twentieth century period, and into the late twentieth-century, the African-American population had begun to increase, ultimately shifting proportions within the neighborhood. Where development occurred, it was in one of two manners – either on vacant parcels that had never been developed or on parcels where an earlier dwelling was demolished to make room for a newer dwelling, as the residents means improved. Near the northern limits of the amendment area, along West 17<sup>th</sup> Street between Marshall Street and Dr. Martin Luther King, Jr Drive, earlier dwellings also gave way to the expansion of institutions such as the Arkansas Baptist College and the Pilgrim Valley Baptist Church. Modern commercial structures came to replace many empty parcels or aged buildings along Wright Avenue.

The expanded boundary of the Central High School Neighborhood Historic District is also eligible under Criterion C in the area of architecture as a local example of an early twentieth century neighborhood that evolved to accommodate the housing booms of the interwar period and the post-World War II era, as the neighborhood continued to evolve and form its identity. The expanded boundary contains examples of various architectural styles and plans from the late nineteenth century to the mid-twentieth century; including Queen Anne, Colonial Revival, Craftsman, American Foursquare, American Small House, and Ranch Houses.

As put in the original nomination, "the buildings in the Central High Neighborhood Historic District reflect the varied popular tastes in architecture during the period 1890-1946; the district's versatility is characterized in its eclectic strain of Colonial Revival, Craftsman, and several variations of Plain Traditional styling."<sup>11</sup> The houses in the expanded boundary complement those in the original nomination, not varying significantly in character or composition. Indeed, resources exhibiting traditional stylistic considerations, such as those of the Craftsman style, with its use of rusticated materials, shed dormers, wide eaves, rafter tails, and knee braces, are predominant. Scattered throughout are other early twentieth century architectural styles and forms, including Colonial Revival and American Foursquare, which also supplement those already found within the district.

Added to this are a number of mid-twentieth century residences characterized by the American Small House or Ranch form, which became common, affordable, and efficient constructions in the post-World War II era as new residents built upon previously vacant parcels or as existing residents replaced older dwellings as a result of improved means during the period. While a number of these originally fell outside of the district's period of significance, they are now included as a reflection of the continued community development of the area during the mid-twentieth century. Much like their predecessors, these later forms also reflect the "varied popular tastes in architecture" for the period and bear witness to the evolution of architectural character within the district as it sought to retain stability and hold fast to its identity in the post-war period.

### Conclusion

The original 1996 National Register nomination characterizes the Central High School Neighborhood Historic District as one "representative of the growth in the first half of this century of a middle and working class neighborhood of mixed use" and one that through "the variation in building scale and decorative detailing seen throughout the district expresses the demographic and socioeconomic variety of its residents."<sup>12</sup> The expanded district offers a more complete representation of the neighborhood as it continued to evolve in the early to mid-twentieth century as development patterns shifted to accommodate new African-American residents, and to some extent, white residents, and to allow existing residents to build new housing as a result of improved means. Expansion of the district in this eastern quadrant anchors the neighborhood to the established district, as well as surrounding neighborhoods of the same period and composition, and creates a more representative, holistic district that reflects the district's significance as a historically interracial, mixed-use neighborhood, reflected in the evolution of its building stock and composition.

It then follows Wright Avenue southeast approximately 0.34 miles to a point at the northwest corner of the intersection of Wright Avenue and Martin Luther King Jr. Drive at UTM E 565035 N 3843558, where it then follows Martin Luther King Jr. Drive north approximately 0.17 miles to a point at the southwest corner of the intersection of Martin Luther King Jr. Drive and West 17<sup>th</sup> Street at UTM E 565043 N 3843828. The boundary then follows West 17<sup>th</sup> Street approximately 0.27 miles west to a point at the southeast corner of the intersection of West 17<sup>th</sup> Street and South Battery Street UTM E 564606 N 3843844, where it follows South Battery Street approximately 0.1 miles south to a point at the northwest corner of the intersection of South Battery Street and West 18<sup>th</sup> Street UTM E 564603 N 3843734. It then follows West 18<sup>th</sup> Street approximately 0.1 miles west to the beginning.

### Boundary Justification (Explain why the boundaries were selected.)

The expanded boundary includes all properties directly associated with the historic development of the neighborhood that retain sufficient physical integrity to reflect their historical associations.

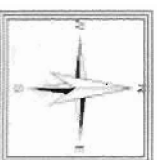
